Executive Summary



Our Company

Epic Airway Systems, Inc. is an early-stage medical device company that has created a new, patented airway treatment that will be an evolution in patient care and does not require clinical trials to get to market

The Challenge

Anesthesiologists, paramedics & emergency medicine physicians provide emergency and elective airway treatments to more than **50MM patients** globally, maintaining breathing during emergencies or sedation during surgery.

Despite their frequency, these procedures are difficult to perform and are high-risk. Patient complications including cardiac events, dental injury and even death are common, adding billions of dollars annually to the US healthcare system; while also placing healthcare providers at risk of infectious disease exposure.

Our Solution

The Epic Airway™ combines two existing technologies for airway treatment into a single solution making it easier to use than traditional devices, while also being safer for patients and healthcare providers, and more cost effective for the healthcare systems.

The Competition

The airway market is mature and has many players (small, medium, large, multi-national) that offer a variety of solutions. The primary competitors are Inter-surgical, Teleflex, Ambu, Mercury Medical, Cook Medical, and Smiths Medical. While there are various devices offered on the market, all require clinicians to make ease of use, airway security, procedural efficiency and patient/provider safety tradeoffs.

The Market Opportunity

The 2022 US airway market was estimated to be \$869M, growing at a CAGR of 8%. Our initial launch will target, US adult specialty surgeries, representing roughly 1.1 MM cases per year at a market size of \$40MM. Growth into all US adult peri-operative surgeries [3.4MM cases/\$120MM] is planned.

With procedures easier and safer to perform by lesser trained clinicians, growth of airway treatments in non-traditional environments is expected.
