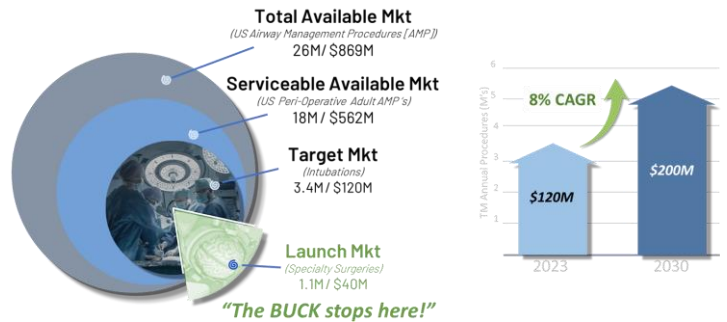


The Epic Airway™ Targets?

Market Analysis?

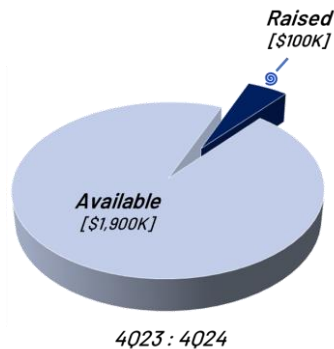

The Opportunity?

Epic Airway Systems (EAS) is an **early-stage** opportunity with a low **\$6MM** current valuation and a **clear pathway to 2026 commercialization** and a projected **10-20X** return in 5-7yrs

The Ask?

With prototyping wrapping up and design freeze planned for 2024, EAS is raising **\$2MM** in the current round to finalize the **detailed design**, develop **manufacturing methods**, purchase capital **tooling** and perform **validation and verification** testing needed for **FDA 510K submission**
